1. Call Meeting to Order

Rob Flood, North Branch Chicago River Watershed Workgroup (NBWW) Monitoring & Water Quality Impairment Abatement Committee Chair, called the NBWW Monitoring & Water Quality Impairment Abatement Committee meeting to order at 12:34pm.

a. Monitoring & NARP Update

Flood gave an update to the Monitoring Committee that NSWRD completed FY24 sampling in February; the next round of sampling will be performed in May 2024. NSWRD and SMC submitted NBWW's Illinois EPA NPDES in-stream monitoring report on behalf of the permit holder members in February 2024.

Brian Valleskey, Geosyntec Consultants, gave an update on the progress of the NBWW NARP. Currently, Geosyntec is working on the NBWW in-stream model which is broken into a hydrologic model and an instream water quality model. The hydrologic model should be completed mid-late April 2024 and can be reviewed by the Monitoring Committee at the April meeting. The in-stream water quality model will be completed around August 2024.

b. NBWW Water Quality Summary Report Request for Proposals Discussion

The Monitoring Committee discussed and reviewed the NBWW Water Quality Summary Report Request for Proposals. The Committee members considered the combined scoring (from Executive Board and
