NBWW MONITORING COMMITTEE MEETING MINUTES

1. Call Meeting to Order

Rob Flood, North Branch Chicago River Watershed Workgroup (NBWW) Monitoring & Water Quality Impairment Abatement Committee Chair, called the NBWW Monitoring & Water Quality Impairment Abatement Committee meeting to order at 12:31pm.

2. Roll Call

6. Old Business

a. Monitoring Update

Flood gave an update to the Monitoring Committee that NSWRD completed FY24 sampling in May; the next round of sampling will be performed in July 2024. There were some rain events during the May sampling which may have contributed to some high E.coli levels noted from the sampling results.

b. Nutrient Assessment Reduction Plan (NARP) Update

Brian Valleskey, Geosyntec Consultants, gave an update on the NBWW NARP. Geosyntec is developing watershed scenarios to inform the NARP implementation approach. Geosyntec is looking closer at the current scenarios (presented at the July and August NBWW meetings) and looking at additional considerations, such as, recent NARP developments (proactive approach to public comments), MS4 permit language updates, realistic projects and possible policy changes. The considerations proposed would hopefully be commented on by NBWW members (possibly through a public survey) to see what they would like to accomplish and the role of the recently approved watershed-based plan. Geosyntec has looked further into the additional scenarios for consideration; analysis of the Skokie Lagoon impacts to the system, urban runoff reductions (25%/50%), impervious area reductions (10%/25%), stream aeration, elimination of DO violations or risk of eutrophication. Geosyntec will provide the NBWW Monitoring Committee a table of scenarios to run through the in-stream model (with pros and cons).

Questions/Answers/Comments

- 1. Has habitat been considered in the scenario considerations?
 - a. Yes, Geosyntec are evaluating dissolved oxygen standard violations and determining if there a way to increase the baseflow dissolved oxygen? Geosyntec is trying to develop a way to increase (reinvigorate) baseflow aeration into the system which could create microhabitat areas in turn for habitat improvement.
 - b. A comment was made about impacts of temperature and stream functionality. This could be an opportunity for the NBWW to prioritize "habitat" in the NARP. Geosyntec is also looking at in-stream aeration measures.

c. Water Quality Summary Report

Geosyntec was requesting a change order request from the NBWW, and the Monitoring Committee was requesting additional information. The draft water quality memorandum (memo) submitted by Geosyntec was not the deliverable that the NBWW members were anticipating. It was decided that a virtual discussion with Rob Flood, Monitoring Chair and Geosyntec to discuss the requested revisions and provide
