NBWW MONITORING COMMITTEE MEETING MINUTES

1. Call Meeting to Order

Rob Flood, North Branch Chicago River Watershed Workgroup (NBWW) Monitoring & Water Quality Impairment Abatement Committee Chair, called the NBWW Monitoring & Water Quality Impairment Abatement Committee meeting to order at 12:34pm.

2. Roll Call

Monitoring Committee members present were **Rob Flood**, North Shore Water Reclamation District (NSWRD); **Larry Bridges**, Skokie Consolidated Drainage District (SCDD); **Chris Johnson**, Illinois Sierra Club; **Alana Bartolai**, Lake County Health Department; **Cecilia Anderson**, Village of Lincolnshire; **Anna Braum**, Forest Preserve District of Cook County; **Leonard Dane**, Hey & Associates; and **Michael Warner**, Gewalt Hamilton. 3. Public Comment - None

4. Approve September 11, 2024 NBWW Monitoring & Water Quality Impairment Abatement Committee Meeting Minutes

Bridges motioned to accept the September 11, 2024, NBWW Monitoring & Water Quality Impairment Abatement Committee Meeting Minutes, seconded by Warner. The motion passed with a unanimous vote.

5. Old Business

a. Water column chemistry monitoring update
Flood gave an update to the Monitoring Committee that NSWRD completed all FY24 sampling. The
Committee reviewed the FY24 summary of the water column chemistry data and discussed potential
hotspots in the watershed. A question was asked if the NBWW knew the fecal coliform source (from the
Total Maximum Daily Load – TMDL), whether it was human (pipe discharge) or habitat driven? The
workgroup did not know but this could be tested for genetic testing. This is a consideration with the NARP
and implementation of the NARP.

b. Nutrient Assessment Reduction Plan update

Brian Valleskey, Geosyntec Consultants, gave an update on the NBWW NARP. Geosyntec developed watershed scenarios to inform NBWW on additional watershed scenarios to run for the NARP. Geosyntec has already run three watershed scenarios and is looking for input from the workgroup for at least another 3 (per the NBWW agreement with Geosyntec). There was discussion with Brian on some of the specifics of the 8 proposed additional scenarios. It was concluded that the Committee would like more time with this decisions and Strelcheck would send out the 8 scenarios to the Monitoring Committee and Executive Board members to rank and prioritize. Strelcheck will combine all the information and present the results at the November 13, 2024 NBWW meetings for further discussion.

Bridges motioned to accept the 2024 Workplan Scorecard as presented, seconded by Johnson.
